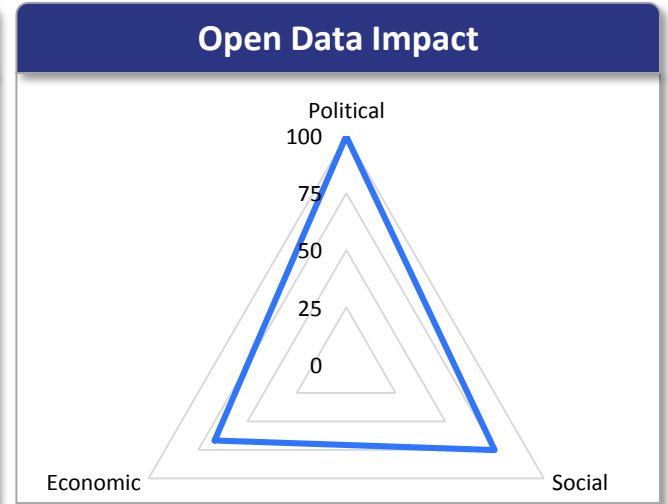
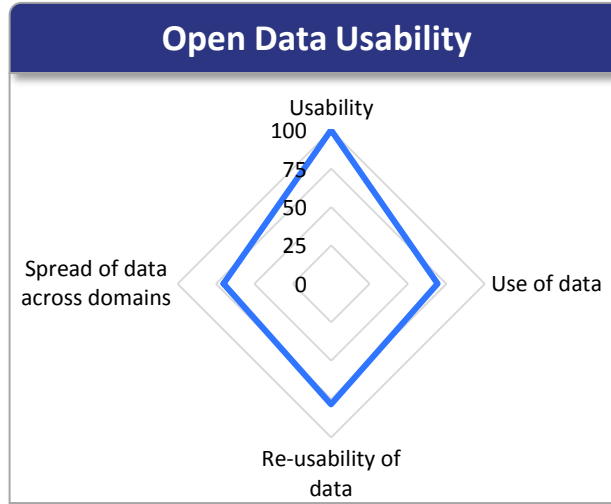
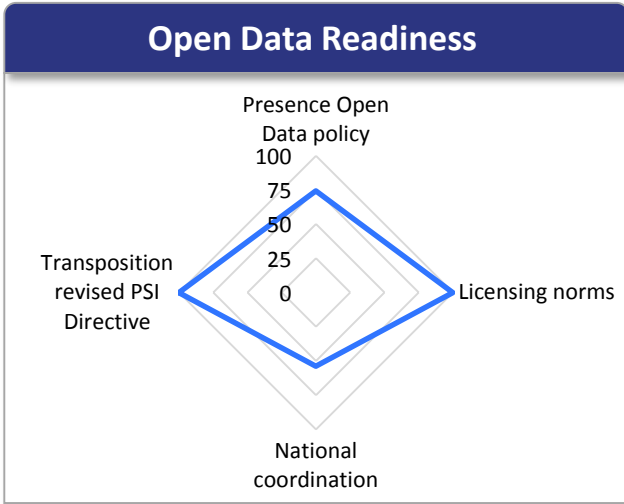
- Little awareness:* Few consumers know about benefits of Open Data.

Best practices

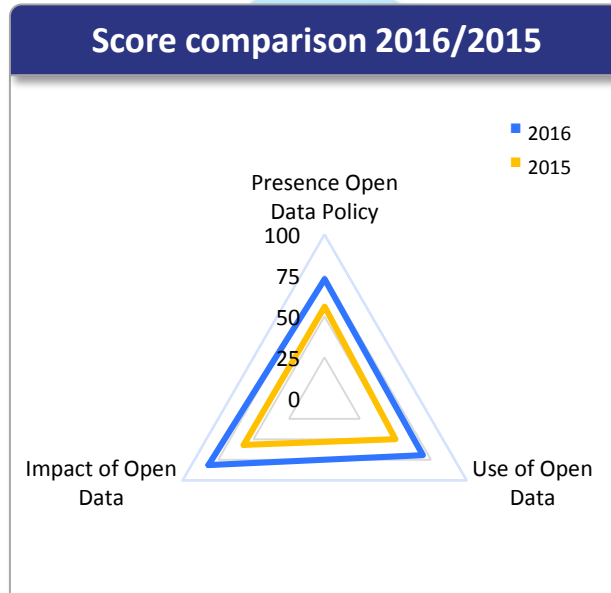
- Drug stores: data on the location of drug stores, their office hours and their drugs selling prices is shared. Citizens and businesses can easily understand the data, as it is published using the standard format and is compliant with the European Statistics Code of Practice.
- Sofia Urban Mobility Centre: providing data on transport vehicles schedules in real time. Thereby, the system helps citizens optimize their use of the urban transportation system and save time.

Progress on barriers

- Four out of five barriers that prevent further publication are addressed in 2015. For example the development of a project that looked at the financing of the national portal. As well as the proposal of an e-learning platform.
- To overcome the barriers that prevent further use, several actions have been undertaken. For example to look for political support and to update the legislation.



- ### Major changes 2016
- Impact of Open Data indicator has increased. Environmental sustainability has increased from medium to high impact and one study about initiatives to open up data was done since last year.
 - The transposition of PSI directive has been completed, which resulted in an increase of the score for Presence of Open Data Policy.
 - The Use of Open Data increased due to an added functionality to monitor the number of visitors.



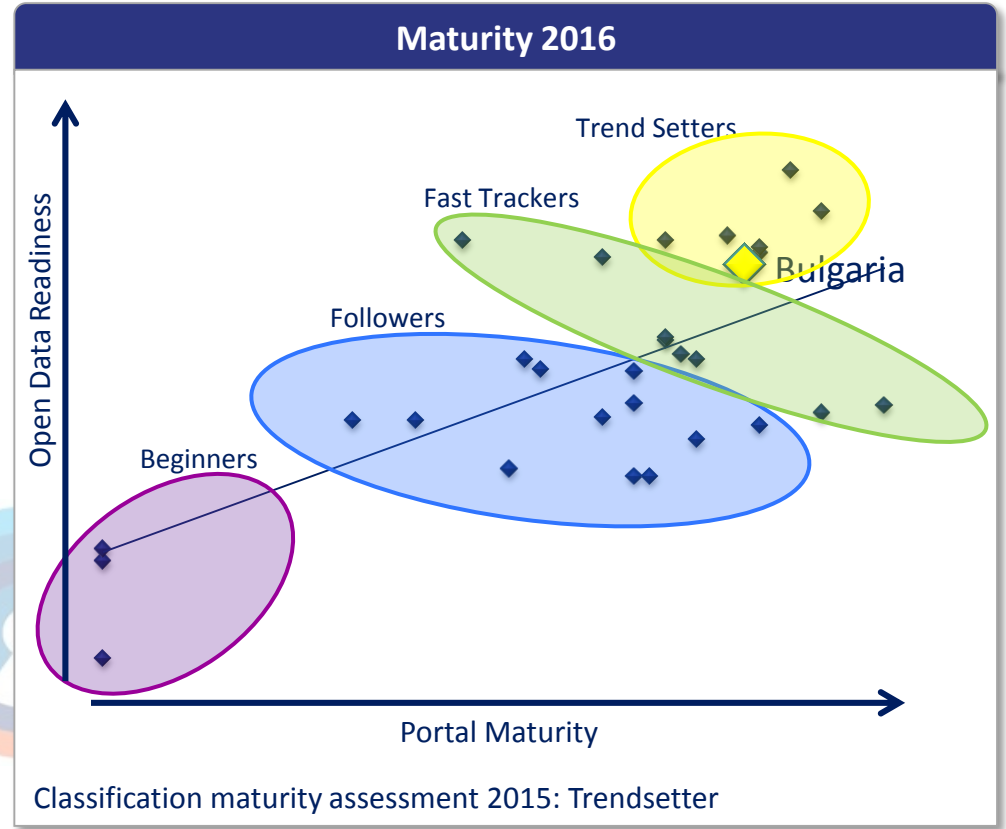
